

ENROLMENT CONDITIONS

Please initial each page to indicate that read and understood these terms and conditions.

The student, applicant, account /fee payer, lawful guardian and / or sponsor are herein collectively referred as the "Student". By acceptance to **Ishago Mining Skills and Operator Training**, and where the student has entered upon studies at **Ishago Mining Skills and Operator Training** pursuant to the contract of enrolment entered into with **Ishago Mining Skills Operator Training** the student shall jointly and severally responsible for the fulfillment of all terms of the agreement.

1. Compliance with ISHAGO MINING SKILLS AND OPERATOR TRAINING Rules and Regulations

The Student will comply with all the rules and regulations of **Ishago Mining Skills and Operator Training** as may be laid down from time to time with the intent and purpose of entering the highest possible academic standard and the best creative results from whole student body.

2. Student Liability for damage or loss

3. Legal Declaration of Indemnity

3.1. 4. Termination of studies

5. Copyright

6. Academic performance

7. Student Fees

7.1 In the event of any fees due by the student being unpaid on due date, the full balance of such fees remaining unpaid shall be come immediately due and payable.

7.2 A statement of accounting reflecting the amount due by the student and certified as correct by the bursar of **Ishago Mining Skills and Operator Training** is hereby agreed to be prima facie evidence of the amount so certified and support any application for summary judgment by **Ishago Mining Skills and Operator Training** against the student.

7.3 In the event of any proceeding s being instituted by **Ishago Mining Skills and Operator Training** against the student then, the signature here to, the student consents, in terms of section 45(1) of Magistrate's Court Act No 32 of 1994, as amended from time to time, to any proceeding which may be instituted in the magistrate's Court which has jurisdiction in terms of section 28(1) of the magistrate's Court, as so amended, notwithstanding the amount of claim.

7.4 The student shall be reliable for all legal costs and charges on an attorney and client scale incurred by **Ishago Mining Skills and Operator Training**, as well as all tracing costs, collection costs, and any other disbursements which are incurred in recovering monies which may at any time be owned by the student to **Ishago Mining Skills and Operator Training**.
